The Cox Frame House is a frame structure built in the 1800's most likely after 1850. It is two bays long by one deep and is two stories in height. The exterior is covered with aluminum siding. The house has a gable roof with a brick inside end chimney in the east and west gable. The facade of the house has a one story enclosed porch. The house has a stone foundation and a cellar. The entrance is on the east side of the house.

A small concrete block rear wing has been built on the rear of the house. There are several small early 20th century board and batten sheds.
