DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The State Line Stone House is a two story stone structure. It is three bays long by two deep with an entrance in the central bay of the facade. In the north gable wall is a deteriorated brick chimney. The exterior walls of this structure are covered with stucco. The gable roof has metal over it with some older wood shingles barely visible along the edges. The window sash is 6/6 and there are no shutters on the house. On the rear of this house is a small two story wing also built of stone. At one time there was a porch on the facade but it has been removed.
