DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Maxwell Brick site is where a mid 18th century brick dwelling stood. An old photograph in the possession of the owners shows that it was a small house similar in proportion to the John Churchman House near Calvert. It was built of brick laid in Flemish bond properly two storeys in height with a gable roof. The picture shows the building in ruins.

The Maxwell Brick Site is marked by foundation stones only. It was an early brick dwelling similar to other homes built prior to the Revolutionary War in Northern Cecil County which reflect the influence of Pennsylvania upon Cecil County Architecture.
