**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Lombard Log and Stone House is a small dwelling that sits in a crossroads. It is one half log and one half stone. The earliest section is believed to be built of log perhaps dating from the early 18th century. This house is two bays by two and two stories in height. Both sections have steep gable roofs, covered with a metal (tin?) roof. The roof has a box cornice with crown moulding. The exterior of the log and stone section are covered with stucco and a shingle siding particularly the second floor. The stone section is of like dimension and has two inside end chimneys both sections have front doors. The window sash has been replaced with modern l/l sash. Some lowered shutters remain on both stories.

Across the facade and down the west gable was a one story porch. The gable end section has been enclosed and now only the facade has a porch. It has an asphalt shingle roof and chamfered support posts.

The Lombard Log and Stone House is important for two reasons. The obvious one is because part of the structure is constructed of logs. The other is that this building possibly dates from the settlement of the Nottingham Lots between 1701-1710.

In 1858 And. Yerkes lived in the house and was a wheel wright.
