DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The 251 House is a frame building erected sometime in the late 1800's or early 1900's. It is two storeys in height and three bays long by two bays deep. The house has a low pitched gable roof covered with asphalt shingles and a box cornice covering the eaves. The house has fairly new wooden siding. Across the facade is a one storey porch. The foundation of the porch is new poured concrete but the old turned posts and brackets have been retained. The window sash throughout is 6/6 -and all of the windows have louvered shutters. The foundation is made of fieldstone as are most in Zion.

A small storey and a half twentieth century addition has been built on the north gable.
