DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Cross Keys or the Krauss Tavern south of Harrisville is supposed to have been built in 1802 by Leonard Krauss, tailor for George Washington. The building is constructed of brick laid in flemish bond on the facade and common bond on the other three walls. Also on the facade is a three brick wide belt course between the first and 2nd storey. Over the windows are splayed brick supports; the other windows have a lentil of bricks laid in an allheader bond. The house is four bays long by two bays deep and is two full storeys in height with an attic. The house has a gable roof covered recently by asphalt shingles, but was originally wood shingle. In each gable wall is an end chimney.

The inn is divided into four rooms on each floor with the southern two rooms being the larger. All but one room on each floor has a corner fireplace with mantel. In the cellar corbeled supports are visible beneath the hearths. The first floor has two very nice mantels which are very alike in design. They have fluted (gouged) pilasters with a frieze decorated with gough carvings. The mantel decorative cornice of pierced dentils. Other important wood work includes the raised paneling in the door jams, the transom with dentil trim, chairrail and a door way with an elliptical arch with inset panels in the jamb. This is similar to Holly Hall. In the rear room on the south side of the house beneath the windows are drawers with wooden knobs. The window sash on the first floor is 9/6 and 6/6 on the second floor. The second floor has several nice nantels which are not as elaborate as those downstairs. Also there are several raised panel doors with spoon locks.

The house has a stone foundation and cellar. An early board and batten door remains with very long strap hinges.

A frame rear wing served as a kitchen and it has been removed. There are several outbuildings (frame) which include a barn and carriage shed.
