DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Christy House is a two-storey frame building three bays long by three wide. This house has a hip roof covered with metal roofing. The facade has a central entrance which is protected by a one-storey porch which has square chamfered columns with brackets. The entrance has a transom with sidelights. On the eastern most wall is a one-storey porch of smaller size. The house has a stone foundation and cellar. There is an interior brick chimney in the central part of the house. The house has a central stair hall with an open string single flight stair including a newel and turned balusters. The house has random width pine flooring. There is a fireplace in the west end of the house but no mantel or chimney. The exterior has been covered with aluminum siding.
