<p>This small two-story brick structure is only two bays wide and one deep. The south facade is laid in flemish bond and the other sides are laid in common bond. The chimney has been removed above the roof. It was originally in the northwest corner. The windows in the basement are boarded up; those on the first floor have 6 over 9 sash and those on the second floor have 6 over 6 sash. In the attic gable is a single window. The interior is trimmed with chair rail and raised panelling above the corner fireplace. There are later additions to the east.</p>
