**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

Two uncoursed stone foundations are located to the north of Stradley Road and off Old Neck Road and near Piney Creek. The larger of the two foundations measures 28' x 24' with varying wall heights due to its deterioration. The walls are about 24" thick. The second foundation is closer to the creek and in better condition. The rectangular shape measures 13' x 8'7" and is approximately 12' deep. The interior wall surfaces are stuccoed.






