The McNamee-Anderson House circa 1870 is a two story frame house located north of Connelly Road and west of Sterrett Road. The house faces south with the main gable running East/West.

The main block is two bays across by one room deep and has had numerous shed additions attached to the main block. The house has been extensively remodeled and totally covered with aluminum. There is an uncoursed stone foundation. The tin roof is of medium pitch.


