1899

J. T. Richards is permanently recorded as the builder of this two story ell shaped frame house on Connelly Road just north of Route 1. The 1899 datestone is set into the west side of the foundation wall. This late 19th century farmhouse is representative of the various asymmetrical_x house types introduced in the third quarter of the century. It was not until the final year of the century that such a house was built in the 8th Election District.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Richards-Rawlings House c. 1899 is a 2½ story L-plan frame house located on the corner of Connelly Road and Route 1. The house is perched on a small knoll and faces west. The front gable runs north/south, while the T extension runs perpendicular to it.

The front block is 2 bays across by one room deep. The back of the house was built in two stages, the first 3 bays with the front block, and the last two were an addition. A side porch (south end of front section) was closed - in by the present owners.

The house rests on an uncoursed stone foundation and is covered with aluminum siding. The slate roof is of a medium pitch. The eaves on the roof are extended with the soffits left open.

The facade is two bays across. There are two windows on each floor including the basement. Located between the basement windows is a datestone with the date 1899 and the name, J. T. Richards.

The south facade is partially covered with the front porch. 6/6 sash windows are located on the second floor as well as the attic level. The south facade of the T-addition is basically plain with 6/6 sash windows and plain trim. A gabled dormer with 6/6 sash is found on the addition roof. It also has extended eaves and open soffits. A central chimney rises out of this section of the house.

The east gable end has a single entrance into the kitchen. Basement access is found on the north side.

The interior has been somewhat remodeled. The interior plan has been altered with the removal of a few walls.

SPECIFIC DATES 1899 BUILDER/ARCHITECT J. T. RICHARDS

STATEMENT OF SIGNIFICANCE

The architectural significance of this house is primarily associated with the 1899 datestone, thus firmly established the date of the structure as well as the stylistic details. The house is one of many ~~that was~~ built during the late 19th century when the area was settled on a larger scale, and some of the larger farms divided. The house retains its 19th century appearance even though it has been aluminum sided. The barn buildings associated with the house also add to the 19th century appearance and its continual operation as a farm.


