DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Page-Edmundson House c. 1860 is a two story three bay by one room board ^{batten} frame house on Pinewood Road northwest of Earleville, Md. The house faces southeast with the main gable running on a northeast/southwest axis.

The two room plan house has a rear shed addition across the NW side. The house rests on a fieldstone foundation and is totally sheathed with aluminum siding. From the owner's description the house had previous battens which were removed when the siding was added. The medium sloped roof is covered with composition tile. A central stove stack has been rebuilt.

The southeast facade is basically symmetrical but the openings have been altered. There are four openings on the ~~first~~ floor and three on the second. The two central openings on the first floor are doors, the southern one having been closed over. The first floor sash have been changed to a single pane sash. The 6/6 sash windows remain ^{in the outer openings}. The central sash has also been changed to 1/1. The eave is boxed with the soffit sloped.

The south gable end has a single pane sash on the first floor and a 6/6 sash on the second. A diamond pane window lights the attic. The same is found on the ~~second~~ ^{North} floor although there is no second floor window.

The northwest side is basically similar to the front with a shed addition across its entire length.

The interior has not been changed too much. A winder stair with beaded board door and closet below is located in the north room which serves as the present kitchen. A mid to late 19th century door with two long narrow panels and ogee inset molding. A small mantel shelf with simple curved brackets is located in the south room.

The second floor is basically plain with access to the attic. A common rafter system supports the roof with the planks exposed on each end. The planks vary slightly in width but on the average measure one foot by an inch thick.

There are no significant 19th century outbuildings associated with the house.

The Page-Edmunson House, however, plain is an important example of board and batten framing in Cecil County. There are only a few documented examples in the county. The method seems to be tied to the plank framing technique that is found throughout the County.

Lewis Page owned the house in 1877, according to the Lake, Griffing, and Stevenson Atlas.
