According to Lake, Griffing and Stevenson ^{JEREMIAH} ~~Jeremiah~~ C. Price owned five hundred and five acres just north of Earleville. The above farmhouse was his residence but he also owned another adjacent house to the north which is gone. The main difference with the above farmhouse and its contemporaries is the irregular four bay main facade. A central hall and stair is flanked by a typically sized room but there is only one opening to the left of the door instead of two. An ell kitchen wing extends westward from the main block.
