World's End Farm

C. 1840-1850

World's End Farm was sold to John B. Price in the 1830's (JS 34/77) by John C. Groome, Trustee. The farm remained in the Price's hands until 1893 when Thomas and Mary Price moved to Smyrna, Delaware. The Price's had sold the farm to their neighbor John Ward Davis whose family owned the land until 1962 when a second Price family bought it.

The two story three bay by one room mid 19th Century house has been moderately remodeled but some significant interior details remain.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

PRICE HOUSE

1840-1850

The Price house circa ~~1850~~ is a two story stuccoed frame house on Ward's Hill Road one-half mile east of Route 282. The farm is located on the south side of the road with the house facing north and the main gable running east/west.

The three bay by one room main block has a two bay by one room 1937 addition to the east. A single story shed addition extends across the entire back of the house. The house has a partial fieldstone basement and is covered with a medium sloped composition tile roof.

The north (main) facade has a central remodeled entrance with a five panel door. The first floor six-over-nine sash have been enlarged. The second floor six-over-six sash are also replacements.

The east gable end has a second floor six-over-six sash on the north side of the large rebuilt interior chimney pile. The end eaves have a plain bargeboard. The west end is almost totally covered with the 1937 addition, and the south side is simalarly treated above the modern shed addition.

The first floor interior consists of two rooms separated by, according to the owners who replaced the plaster, horizontal plank walls. The west room mantel was removed but the east parlor mantel remains. Fluted pilasters support a plain frieze with prosecting end blocks. A beveled shelf has a simple bed molding. A small stair closet with a four panel door and cast iron latch is found to the south of the fireplace. The earlier winder stair has been replaced with a straight flight. A simple chair rail also remains in this room with a small top molding and lower corner bead. The mid section is plain. The door surround has a typical mid 19th Century thumb and astracal backband.

On one of the second floor doors in a box lock with the patent date July 21, 1863. This lock could be later and may not be the date for the initial construction of the house.

The only significant outbuilding is a frame meat house with horizontal studing mortised into the corner posts and corner braces joining plate and corner posts. There is a steep wood shingle roof with exposed joists. The western board door retains its long strap hinges. The original meat hooks remain inside. The vertical board siding has been covered with asbestos.
