C. 1840

This traditional two story five bay by one room center hall frame house stands on part of a tract called "Colleton". The tract was sold to Mary Budd's father Nehemiah Garrison in 1840 by George D. Hollis. (GMC 3/79) R. H. Hayes appears on the 1877 Lake, Griffing and Stevenson <sup>ATLAS</sup> along with <sup>OWNER</sup> Mrs. M. Budd, as a probable tenant farmer.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE***Supp -*

The<sup>A</sup> Hayes House c. 1840 is a 2 story 5 bay center hall frame house on Ward's Hill Road and west of Warwick, Md. The house faces north with the main gable running east/west.

The five bay one room structure rests on a fieldstone base-ment and is partially covered with aluminum siding. Exposed weatherboards are found on the south side of the house. The medium sloped roof is covered with composition tile. A 1½ story 2 bay one room half gable kitchen wing extends south of the main block.

The north side has typical symmetrical fenestration with a central entrance. The central door has been replaced but a 4 light transom is found overhead. The 6/6 sash windows have molded surrounds. There are no shutters. A single bay gabled front porch covers the central bay and is supported by late 19th century turned posts. A plain box cornice stretches across at eave level.

The west end is typically plain with two 2/2 attic sash and plain bargeboards. Brick stacks rise out of each end with an elaborate corbelled cap.

The east end has a 6/6 sash on each floor and a 2/2 attic light.

The kitchen wing is simarly detailed but retains a seamed tin roof. A tall stuccoed stack rises out of the gable end. Entrance is gained through the east wall with an adjacent 6/6 sash. Two 6/6 sash illuminate the second floor. The south gable end is plain and partially covered with tar paper. The chimney stack has an exposed firewall. The west end of the wing has a 6/6 first floor light and 3/3 second floor sash.

The interior of the main block has an enclosed central stair with flanking parlors. The door reveals into each room are paneled. The fluted door surrounds have bulls-eye corner blocks. The 5 panel doors have three horizontal panels above the lock rail and two vertical panels below. The east parlor mantel has a molded surround with a molded and stepped mantel shelf. A four door paneled cupboard is found to the north of the fireplace.

The kitchen has a large cooking fireplace with an enclosed beaded board winder stair and closet to the east.

Various 19th century frame barn buildings are located southeast of the house. A fieldstone dairy is located next to the pump and near the kitchen. The structure retains its wood shingle roof. Located behind the dairy is a windmill and the remains of a water tower.

<sup>Budd-</sup>  
 The <sup>A</sup>Hayes House is a fairly significant mid 19th century "Georgian" farmhouse with uncommon exterior and interior details. The corbelled brick stacks are unusual and the interior woodwork varies slightly from the expected. The interior room arrangement and detailing ~~seems to~~ remain basically intact throughout the house. A circular drive once provided access to the house but has not been used in many years and a central circular mound is all that remains. The house appears to have been owned by ~~the~~ Mrs. M. H. Budd ~~or R. H. Hayes~~ in 1877.

R. H. Hayes owned 1 acre in 1877 - native Cecil Co. 1812.
