DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This is a two storey frame house which appears early Victorian from the facade but the rear 1/2 indicated a greater age.

Five bays in length at the ground level (door center) and 5 at the second level the house rests on solid brick foundations built into the side of a hill similar to a N. Md. bank barn.

The roof plan is "A" frame and there are 2 chimneys at the N gable and a single chimney at the S gable to the east front of the roof ridge. The front chimney at the N gable is ca. Victorian and flush with the interior of the gable wall. The rear (NW) chimney is on the exterior is of massive design and double flue. The SW chimney was of the same design and at the exterior - however it was removed some years ago.

at the front of the roof is a Victorian gable. To the facade is a 1 storey porch of Victorian design. The door has a 4 1/2 transome the door is double. All windows are 4/4.
