7. Description

The House Near Ironsides was first identified by J. Richard Rivoire in the 1970's. It was then described as a two-story, three-bay, side-gable dwelling with a 1 ½ story addition attached to the gable end. At the time of the original survey, the house was in a deteriorated condition. The property was not located during a recent field investigation and is presumed to have been demolished.
