


DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This is a rather simply constructed frame building of the circa 1900 period possessing an "A" frame roof the ridge of which runs E-W and is three "bays" in length, viz: W.D.W. All windows are 6/6 sash and the late Victorian panelled door has an inset 3 pane fan. At the S. elevation (fret wall) is a plain shed roofed porch while the N. elevation has almost completely collapsed due to a rotted sill. To the E. end is a later 1 storey 1 room addition. The bldg. (orig.) is two rooms in length & ~~two~~ two in depth.
