FROM JOISTS AND USABLE INTERIOR MOULDINGS IT DOES NOT APPEAR THAT THE HOUSE DATES EARLIER THAN 1830-1840. THERE WAS A FULL CELLAR ~~AT THE~~ BENEATH THE MAIN BLOCK FORMED BY BRICK FOUNDATION WALLS. THERE IS A ONE STORY ADDITION OF EA. 20TH C. DATES TO THE N. END.

IN THE IMMEDIATE VICINITY OF THE ORIGINAL SITE IS A CORN CRIB OF EA. 19TH C. (?) DATE. IT WOULD BE INTERESTING IF THIS CORN CRIB WERE OF THE DATE OF THE HOUSE SINCE IT DISPLAYS BUILDING CHARACTERISTICS OF PERIOD 50+ YEARS EARLIER.
