Description:

The William Marshall Property II is a 2-story, 3-bay I-house on the west side of Middletown Road in the vicinity of Pomfret, Charles County. Constructed circa 1900, the building has a 2-story rear ell and a full-width screened porch on the front elevation. The structure has a standing seam metal, side-gable roof with a brick chimney at both end walls. The 2-story ell also has a standing seam metal roof and a brick chimney at the end wall. The I-house is of wood-frame construction with vinyl siding; the foundation is not visible. Most windows are 6/6 double-hung wood. The majority of windows have wood shutters with three raised panels.

Significance:

The I-house on the William Marshall Property II is an undistinctive example of a common architectural style. The addition of an enclosed, screened porch has introduced an architectural element out of character with the intent of the original design. The porch, which is more than 1-story tall with vertical screens, is of a large proportion and has a significant visual impact on the elevation. In addition, the associated outbuildings are also undistinctive examples of common architectural types. William H. Marshall purchased 0.80 hectares (2 acres) of land in 1899 and constructed a house on the property circa 1900. The property has remained in the Marshall family since that time and was conveyed to Henry A. and Rose Ella Marshall in 1967. Rose Marshall is the present owner of the land, which retains its original size.

The William Marshall Property II is a 2-story, 3-bay I-house on the west side of Middletown Road in the vicinity of Pomfret, Charles County. Constructed circa 1900, the building has a 2-story rear ell and a full-width screened porch on the front elevation.

The structure has a standing seam metal, side-gable roof with a brick chimney at both end walls. The 2-story ell also has a standing seam metal roof and a brick chimney at the end wall. The I-house is of wood-frame construction with vinyl siding; the foundation is not visible. All windows are 6/6 double-hung wood unless noted otherwise. The majority of windows have wood shutters with three raised panels.

The south, or front elevation is concealed on the first story by a full-width, hipped-roof porch. The porch is completely screened and has a centered wood screen door. The fenestration pattern of the I-house is symmetrical; there are two windows and a centered wood door on the first story and four windows on the second story.

The east and west elevations of the I-house, and the north elevation of the ell, have no fenestration. The north elevation of the I-house has a first story window in the first bay, and a second story window in the first and third bay. The east elevation of the 2-story rear ell has a wood door with an aluminum awning and a window on the first story, and a window on the second story. The west elevation of the ell is concealed on the first story by a concrete block, shed-roof addition. The addition has a wood door and a 1/1 double-hung aluminum window. The second story of the ell has one window.

There are seven outbuildings associated with the property. The first outbuilding is a small, prefabricated steel shed erected circa 1975. The shed is located northwest of the house.

The second outbuilding is a shed with an asphalt sheet, shed roof. Constructed circa 1950, the shed is of wood-frame construction and is located northwest of the house and north of the prefabricated shed.

The third outbuilding is a chicken house with a metal shed roof. Constructed circa 1920, the chicken house is of wood-frame construction and is located north of the house and northeast of the two sheds.

The fourth outbuilding is a privy with a metal gable roof. Constructed circa 1900 on the Middletown school property and relocated to the William Marshall Property II circa 1950, the privy is of wood-frame construction and is located north of the house, northeast of the two sheds, and northwest of the chicken house.

The fifth outbuilding is a shed with a metal shed roof. Constructed circa 1900, the shed is of wood-frame construction and is located approximately 1 meter (3 feet) east of the privy.

The sixth outbuilding is an equipment shed with a gable roof covered with both asphalt sheets and shingles. Constructed circa 1920, the equipment shed is of wood-frame construction and is located north of the house and the other five outbuildings.

The seventh outbuilding is a corn crib with an asphalt sheet gable roof. Constructed circa 1920, the corn crib is of wood-frame construction and is located north of the house and five of the outbuildings, and west of the equipment shed.

The property is located on the west side of Middletown Road at the junction with Pomfret Road. The site is level, and there are woods to the north and fields to the west. The property's setting is a rural area of woods, farms, small cottages, and ranch houses.




