A two part frame farmhouse of basic late-Federal architecture, Hall's Lot reflects the persistence of certain popular building styles long after their succession by other designs--in this case the Federal "townhouse" type built here during the late 18th and early 19th century. The three bay, side stair hall-double parlor plan is basically the same as such earlier Federal buildings as Mt. Republican (CHAS-17), Hard Bargain (CHAS-41), Oakland (CHAS-195) and Timber Neck (CHAS-297), to name but a few. Hall's Lot has one interior and one exterior chimney at the east end of the main block, and extending out from the same elevation, a two-story kitchen wing, also with an exterior end chimney. Among several interesting features is an elliptical fanlight over the wide doorway connecting the double parlors. With flat wood muntins, its design is not unlike that of the much more elaborate, traceried, leaded glass fanlight over the drawingroom doors of West Hatton (CHAS-39).

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Hall's Lot is an interesting frame house that illustrates the continued popularity of the Federal "townhouse" architecture so prevalent here during the late 18th and early 19th centuries.

Of a two part composition, the main block is two-storys high and three bays in width on both side elevations. The principal facade faces south and the entrance door, with over and side lights, occupies the first bay from the west end. The two adjacent windows and three second floor windows are all of 6-over-6 sash and have louvered exterior shutters. The first floor level is sheltered by an open porch with brick platform (modern) and round tapered posts. The same fenestration and door placement is repeated on the north side of the house. Here, a small pedimented porch of modern construction shelters the door. The west end of the house is two bays deep at both floor levels. The shallow gable roof, sheathed with shingled tin, has overhanging eaves on all sides of the house. At the east end of the house is one interior and one exterior chimney that serve first floor fireplaces. The northeast exterior chimney is covered by a two-story, two bay wing lower than the main block but of the same architectural styling. Its four south windows and three north windows frame 6-over-6 sash and have louvered shutters. A north door occupies the first bay from the east end. On this same side is a one-story porch with shallow shed roof, block and turned posts and balustrade. At the east end of the wing stands a single exterior chimney for a large first floor fireplace. The house is built on brick foundations and has beaded siding that is a modern replacement of the original clapboards.

The interior of the main block reflects the Federal origin of its architectural styling, having a side stair hall and adjacent double parlors. All of the woodwork, except chairrails added by a previous owner, appears original and is of a fairly simple design. Of particular interest is a large doorway between the two first floor rooms that has an elliptically shaped fanlight with flat wood muntins. Overall, it is of a design reminiscent of the very handsome leaded fanlight over the drawingroom doors of West Hatton (CHAS-39).
