DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small, one and a half-story frame house is designed in a style known as a "shotgun house." It is a design that is rarely used for farm houses in southern Maryland; though in the states further South, it is often the predominate plan for the rural houses of blacks and is often found as well in cities and mill towns. Like the other "shotgun houses," this one consists of multiple rooms (in this case, three) aligned back to back with the gable end oriented toward the road and serving as the principal facade. In this house, the facade consists of only one bay, which is typical of the "shotgun design." The front door is sheltered by a small shed porch, above which is let a double-hung sash window in the upper half story. The back length of the original two-room block was designed similarly, though it probably had a larger porch to shelter household and farm equipment.

The structure is balloon frame and is sheathed with weatherboards that are unpainted. The corners are covered with unpainted trim boards, the only bright colors to the facade being given by the white trim around the upper window and the white panel door with four lights in the upper half. There are no windows along either side of the width. To the back of the house, a small one-room addition with shed porch has been attached to the original two-room block.

The interior consists of two rooms downstairs, plus the kitchen addition, and two rooms upstairs. A boxed, straight flight of stairs leads to the upper chambers. The walls and ceilings are lathed and plastered. Originally, the interior was heated by wood stoves, which have now been removed, and oil is used. A wood stove was installed in the new kitchen and is still in use. The wood for this stove is neatly stacked on the back porch and in cords in front of the porch.

STATEMENT OF SIGNIFICANCE

According to the owner, Mr. Dyson, this house was built in the early 1900's as a tenant house for both white and black tenant families who worked on his family's farm. It, therefore, represents the type of house occupied by the rural working class of both races in the late 19th and 20th centuries.

Though the possessions of the occupant family were by no means abundant, everything in and around the house was kept clean and neatly organized. The pictures of the grounds around the house show this attention and care. Note, for example, the neatly stacked cords of wood on the back porch and in the back yard, along with the stacked tobacco sheds. This arrangement of objects and physical space reveals important personal values of the occupant family, the Mahoneys. Comparing the placement of objects and use of space at this site and at other tenant houses -- for example, the Taylor House near La Plata -- indicates basic similarities as well as crucial individual differences in the sense of self and of home environment among black tenant farmers as a class.


