Description:

The George M. Sullivan Property, constructed in 1946, is a 2-story, 6-bay commercial building with a flat-roof and a 1-story, flat-roof addition on its west elevation. The building is of concrete block construction with a stuccoed exterior and foundation. There is a pent-roof projecting bay on the front, or east elevation with two recessed entrances and multi-pane display windows. The structure also contains a brick exterior chimney and most of the windows are wood, 1/1, double-hung. The property is located in a commercial area along Leonardtown Road, a major regional thoroughfare.

Significance:

George M. Sullivan purchased the 579 square meter (6,240 square foot) property in 1946. According to a long time local resident, the building was constructed on the land in 1946 for two shops. The property was sold a number of times until the current owner, the Southern Maryland Tri-County Community Action Committee purchased it in 1990. The building is not a significant resource, as it is an undistinguished example of a common building type. The building's architectural integrity has been compromised. The original 2-story, rectangular form and plan has been altered by the 1-story addition on the west elevation. The enclosure of several window openings has altered the building's original fenestration pattern.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The George M. Sullivan Property is a 2-story, 6-bay commercial building with a flat roof, located on the west side of Leonardtown Road in Hughesville, Charles County. According to a long time resident of the Hughesville area, it was constructed in 1946. The building has a 1-story, flat roof addition on the west elevation. There are no outbuildings associated with the property.

The structure has a flat roof with a parapet. The west addition has a flat roof and an exterior brick chimney. The building is of concrete block construction and has a stucco exterior and foundation with a brick veneer on the east (front) elevation. The windows are wood, 1/1 double-hung, unless noted otherwise.

The first story of the east, or front elevation has a typical false-front commercial facade with a brick veneer. The first story has a typical storefront arrangement with a 1-story pent-roof bay projecting from the elevation, which contains two recessed entrances. The north entrance has a 1-light, wood-panel door with a wood lintel. The south entrance has a 9-light, wood-panel door with a wood lintel. The projecting bay also has two, 3-light, wood-frame and two, 2-light, wood-frame display windows. The second story has two paired windows with shutters.

The south elevation includes the main block and the 1-story, flat-roof addition projecting from the west (rear) elevation. The main block has a 3-light door and two, 3-light wood windows on the first story. Two other window openings have been infilled with plywood. The second story has a wood door, two paired windows, and three single windows. The south elevation of the rear, flat roof addition has no fenestration.

The west, or rear elevation is partially concealed by the rear, 1-story, flat-roof addition. The second story of the main block has three windows. The first story of the flat-roof addition has an exterior brick chimney, and three entrances; a double metal door with an iron-bar security door, a metal door, and a wood door. A window opening infilled with wood is also located in the addition.

The north elevation contains the main block and the rear, 1-story, flat-roof addition projecting from the west elevation. The first story of the main block has two, wood, 3-light windows. The second story has six, wood, 1/1 double hung windows. The 1-story, flat-roof addition has one, wood, 3-light window.

The property is located on the west side of Leonardtown Road. There are twentieth century commercial buildings to the north and south. A light wooded area is located west of the property. The property's setting is a commercial area along Leonardtown Road, a major regional thoroughfare.

8. Significance (Continued)

Gannett's 1904 Gazetteer of Maryland defined Hughesville as a "post village...on the Washington, Potomac and Chesapeake Railroad" (Gannett 1904: 43). By 1906 the community was known as "a station of the Southern Maryland Railroad...and a banking town" with two (2) physicians, two (2) general stores, two (2) blacksmiths, a grist and saw mill, a flour mill, an undertaker and livery, a hotel, a hotel and saloon, a grocer and saloon, an insurance salesman, and a population of 150 (Maryland 1906: 667).

The building is an example of mid-twentieth century commercial architecture. The development of the automobile created a rise in roadside commercial development, particularly among primary routes. About the time of World War I, shops began to appear along these routes and included such structures as gas stations, produce stands, restaurants, and motels. To capture the public's attention, visible signs often appeared on the front of businesses, on billboards, and on the sides of barns and other structures. Because of an emerging society where most families owned an automobile, business owners often relocated in areas that were once rural, where land was cheaper and could accommodate large parking lots. These developments led to a decline in urban retail districts all over the county after World War II (Liebs, 1985: 5-9).

Early twentieth century rural, small-scale commercial buildings were often adaptations of simple dwelling designs. Most were of frame construction and 1 to 2-stories in height. Often in 2-story structures, the upper story served as living quarters for the proprietor. These buildings usually had front-gable or parapet-flat roofs and featured large display windows and a sign located over the main entrance. They usually had little decorative features, limited to transoms over the door or decorative signs (Liebs, 1985: 5-8).

The George M. Sullivan property is an example of a false-front commercial building. The false-front was a common vernacular type of commercial building. It is characterized by a portion of the front facade which extends vertically and horizontally over the corners of the building. Other common features include a symmetrical fenestration with double-hung wood windows, cornice detail, recessed entrances, and multi-pane display windows (Gottfried and Jennings, 244-245).

8. Significance (Continued)

National Register Evaluation:

Constructed in 1946, the George M. Sullivan Property is not eligible for the National Register of Historic Places. The property is not eligible under Criterion A, as research conducted indicated no association with any historic events or trends significant in the development of national, state, or local history. Historic research indicates that the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. It is not eligible under Criterion C, as it is an undistinguished example of a common building type. The building's architectural integrity has been compromised. The original 2-story, rectangular form and plan have been altered by the 1-story addition on the west elevation. The enclosure of several window openings has altered the building's original fenestration pattern. Finally, the structure has no known potential to yield important information, and therefore is not eligible under Criterion D.


