Description:

The Hamer / George Property is a 1½-story, 5-bay, side-gable cottage, constructed in 1940, on the north side of Burnt Store Road in Hughesville, Charles County. The residence contains a gable addition on the east elevation, a shed roof dormer on the north (rear) elevation, and two front-gable dormers on the south (front) elevation. The property has one outbuilding. The structure is a prefabricated, wood-frame, gambrel roof shed with an asphalt shingle roof. The shed is located northeast of the main house. The property is set in a rural area along Burnt Store Road.

Significance:

The Hamer / George Property is a side-gable vernacular cottage on a .239 hectare (.59 acre) parcel on the north side of Burnt Store Road in Hughesville, Charles County, in southern Maryland. According to the records of the Charles County Tax Assessor, the house was constructed in 1940. The structure is not a significant resource, as it is an undistinguished example of a common building type. It has been significantly altered with the 1-story, gable addition projecting from the east elevation, and a shed-roof dormer has been added to the north elevation.

The Hamer / George Property is a 1½-story, 5-bay, side-gable cottage, constructed in 1940, on the north side of Burnt Store Road in Hughesville, Charles County. The residence contains a gable addition on the east elevation, two gable dormers on the front (south) elevation, and a shed roof dormer on the rear (north) elevation.

The structure has an asphalt shingle, side-gable roof with an interior brick chimney at the intersection of the original section of the house and the gable addition. The residence is of masonry construction with a brick exterior. It also has a 4-light, wood-panel front door on the south elevation. A wood-panel door with an aluminum storm door is located on the east elevation and a wood-panel door with a shed roof entry porch supported by wood posts is located on the north elevation. The windows are primarily wood, 6/6 double-hung with metal storm windows.

The interior access was not available at the time of the survey.

The property has one outbuilding. The structure is a prefabricated, wood-frame, gambrel roof shed with an asphalt shingle roof. The shed is located northeast of the main house.

The property is a lightly wooded site approximately 213 meters (700 feet) west of the intersection of Burnt Store Road with Leonardtown Road. Its setting is a rural area containing mid-twentieth century residences.

Potomac and Chesapeake Railroad" (Gannett 1904: 43). By 1906 the community was known as "a station of the Southern Maryland Railroad...and a banking town" with two (2) physicians, two (2) general stores, two (2) blacksmiths, a grist and saw mill, a flour mill, an undertaker and livery, a hotel, a hotel and saloon, a grocer and saloon, an insurance salesman, and a population of 150 (Maryland 1906: 667).

The Hamer / George Property is an example of a vernacular cottage. Between 1870 and 1940 the vernacular cottage style was typically built for Americans of modest means. They are characterized by simple ornamentation and mass-produced components, such as door frames, moldings, sash and window units, and porch decoration. The development of post-Civil War machinery capable of producing large amounts of standardized housing elements, such as those found in cottages, contributed greatly to the development of the modern American housing industry. Designs for vernacular cottages were obtained from popular magazines, such as House Beautiful, or carpenter's and builder's journals, such as American Builder. A variety of front-gable, side-gable, cross-gable and hipped roof frame cottages were developed in the early to mid-twentieth century. Front-gable and hipped roof cottages are primarily 1 to 1½-stories tall, 3-bays wide and several rooms deep. Side-gable and cross-gable structures are usually 2 to 2½-stories tall, are typically 2 to 3-bays in width and vary from one to three rooms deep. They usually include a porch covered with a shed roof. Porches are supported by posts often containing machine-produced Victorian ornamentation. Some cottages feature ornamentation drawn from Craftsman style or Colonial Revival architecture (Gottfried and Jennings 1988, viii-xv).

National Register Evaluation:

Constructed circa 1940, the Hamer / George Property is not eligible for the National Register of Historic Places. It is not eligible under Criterion A, as historic research conducted indicates no association with historic events or trends significant to national, state, or local history. Historic research also indicates that the property has no association with persons who have made specific contributions to history, and therefore, it is not eligible under Criterion B. It is not eligible under Criterion C, as the structure is an undistinguished example of a common building type, and the historic character of the property has been altered. The integrity of the original rectangular form and plan of the house has been compromised with the 1-story, gable addition projecting from the east elevation. The addition also compromises the integrity of the original fenestration pattern and massing on the south, or front facade with two additional bays of windows. The dormers on the original house are covered with vinyl siding and a shed roof dormer has been added to the rear elevation. Finally, the property has no known potential to yield important information, and therefore, is not eligible under Criterion D.




