### Description:

The Katherine Chappellear Property, constructed in 1916, is located on the north side of Prince Frederick Road in Hughesville, Charles County. The residence is a 2½-story, 3-bay front-gable cottage with a parged, stone foundation and asbestos siding. The metal roof has exposed rafter ends and a central brick chimney. A 1-story addition, constructed circa 1985, extends from the east elevation and a 2-story addition is located on the north (rear) elevation.

### Significance:

Katherine Chappellear acquired a 1.6 hectares (4 acre) parcel from the heirs of George Chappellear in 1916, and constructed the cottage on the property. Katherine and Frederick Chappellear retained the property until 1944, when the residence and land was transferred to John and Pearl Combs. The Combs family retained ownership until 1973, when the current owner, B. Clark King, acquired the property. The property size of 1.6 hectares (4 acres) has remained constant. The property is an undistinguished example of a common architectural style. In addition, the architectural integrity has been compromised through the conversion of the residence into two units and the construction of two additions.

The Katherine Chappellear Property, constructed in 1916, is located on the north side of Prince Frederick Road in Hughesville, Charles County. The residence is a 2½-story, 3-bay front-gable cottage with a parged, stone foundation and asbestos siding. The metal roof has exposed rafter ends and a central brick chimney. A 1-story addition, constructed circa 1985, extends from the east elevation and a 2-story addition is located on the north (rear) elevation.

The south, or front elevation has a central entry with a front-gable, entry porch, supported by wood posts. There are two, 6/6 double-hung, wood windows on the first story and three, 6/6 double-hung, wood windows on the second story.

The west elevation has one, 3-light window at the basement level and three, 6/6 double-hung, wood windows on both the first and second stories.

The north, or rear elevation is obscured by the 2-story addition. The first story of the addition is an enclosed porch with two pairs of 1/1 double-hung, windows and a door. A wood staircase extends from grade to the second story, which is an open porch with an iron railing and corrugated plastic roofing. One, 1/1 double-hung, window and a door are located on the second story.

The first story of the east elevation is covered by the modern 1-story addition. The second story has three, 1/1 double-hung windows.

According to the owner, all original cabinetry and wood trim on the interior of the structure was replaced after approximately 1975.

There are two other buildings associated with this property. The first is a modern, metal commercial building, constructed in 1987. The commercial building is located north of the house.

The second structure is a shed with an attached carport, located northwest of the house and west of the commercial building. The shed is a circa 1920, small tobacco barn, which the current owner modified for use as storage. The attached carport was constructed in 1987.

The property is located along Prince Frederick Road. Concrete steps at the front of the property lead from the road, up an embankment to the front of the residence.

Katherine Chappellear acquired a 1.6 hectares (4 acre) parcel from the heirs of George Chappellear in 1916, and constructed the cottage on the property. There are no detailed, published historic maps of Charles County, Maryland that locate and indicate ownership of structures, however. Katherine and Frederick Chappellear retained the property until 1944, when the residence and land was transferred to John and Pearl Combs. The Combs family retained ownership until 1973, when the current owner, B. Clark King, acquired the property. The property size of 1.6 hectares (4 acres) has remained constant.

The Maryland Colony was granted by King Charles I to Lord Baltimore in 1632. Two years later, the first European community was established at St. Mary's City. Subsequent colonization moved north, along the Potomac and Patuxent Rivers. As settlers migrated away from St. Mary's City, the formation of a new county became necessary, and Charles County was founded in 1658. This area was originally inhabited by Algonquins of the Powhatan Confederacy. Road clearing began in the mid-eighteenth century as a result of the establishment of port towns and Maryland's rising population. Tobacco cultivation dominated the economic and social life of Charles County until the mid-nineteenth century when soil exhaustion required agricultural diversification. The introduction of rail lines in the late nineteenth century linked Charles County with the north and south, encouraging trade. While the suburbanization of Charles County was ensured by the widespread availability of the automobile in the mid-twentieth century, the County has retained its rural and agricultural character.

The area that became Hughesville was located in Lord Baltimore's grant of 6,879.9 hectares (17,000 acres) of Newport Hundred to Major William Boarman during 1650-1699. This land included the region "east of Zachiah Swamp" and became known as Boarman's Manor. Hughesville does not appear on an 1840 Map of a Part of Maryland, and Fisher's 1852 Gazetteer of the State of Maryland did not list the community. Hughesville was located at the crossroads of two of the main routes through Charles County: Burnt Store to Patuxent City and on to Annapolis, (Burnt Store Road and Prince Frederick Road/Route 231) and Bryantown to Charlotte Hall and on to St. Mary's City (Leonardtwn Road/Route 5). Accordingly, Hughesville is shown on Martenet's 1866 Map of Maryland, Atlas Edition. The 1871 State Gazette and Merchants and Farmers Directory for Maryland and the District of Columbia called Hughesville a "post town." Bland's 1887 Maryland Directory and State Gazetteer listed both Episcopal and Roman Catholic churches in Hughesville as well as a Friends' school, four (4) general merchandise stores, two (2) saloons, two (2)




