Description:

The Frank Canter Property is a 1½-story, 3-bay, front-gable cottage on the north side of Scout Camp Road in the vicinity of Hughesville, Charles County. Constructed in 1926, the building has a hipped-roof porch on the front elevation, a 1-story addition on the rear elevation, and a screened porch on the east elevation. The structure has an asphalt shingle, front-gable roof with an interior brick chimney. The rear addition has an asphalt shingle, shed-roof and an exterior brick chimney. The cottage is of wood-frame construction with wood siding, and it has a concrete block foundation. The windows are 6/6 double-hung wood.

Significance:

Constructed in 1926, the Frank Canter Property is an undistinctive example of a common architectural type. In addition, the form and massing of the original cottage have been altered by the construction of the rear shed-roof addition and by the screened porch. According to deed research, Frank Canter purchased the .4 hectare (1 acre) lot in 1925. According to the records of the Charles County Tax Assessor, a house was constructed on the premises in 1926. The parcel associated with the premises increased to 1.2 hectares (3 acres) when its current owners, Marguerite C. and Charles R. Canter, acquired it in 1972.

The Frank Canter Property is a 1½-story, 3-bay, front-gable cottage on the north side of Scout Camp Road in the vicinity of Hughesville, Charles County. Constructed in 1926, the building has a hipped-roof porch on the front elevation, a 1-story addition on the rear elevation, and a screened porch on the east elevation.

The structure has an asphalt shingle, front-gable roof with an interior brick chimney. The rear addition has an asphalt shingle, shed-roof and an exterior brick chimney. The cottage is of wood-frame construction with wood siding, and it has a concrete block foundation. The windows are 6/6 double-hung wood unless noted otherwise.

The south, or front elevation has a hipped-roof porch supported by turned wood posts. The porch has a brick foundation. The elevation has a symmetrical fenestration pattern, with a 4-light wood door centered between two first story 6/6 double-hung windows. There are two 6-light awning windows in the gable end.

The west elevation has an irregular fenestration pattern, with one single and one pair of 6/6 double-hung windows.

The north, or rear elevation is concealed on the first story by the shed-roof addition. There are two 6-light awning windows in the gable end. The floor of the addition is elevated above grade on concrete blocks, and it has an exterior brick chimney. The north elevation of the addition has three 6/6 double-hung windows, and the west elevation has a pair of 6/6 double-hung windows. The east elevation of the addition is concealed by the screened porch.

The east elevation of the cottage is concealed on the third bay by part of the screened porch. The fenestration pattern is symmetrical, with two 6/6 double-hung windows in the first and second bays, and a door opening onto the screened porch in the third bay.

There are four outbuildings associated with this property. The first outbuilding is a garage with an asphalt shingle, side-gable roof. Constructed circa 1930, the garage is of wood-frame construction with wood siding, and it is located east of the cottage.

The second outbuilding is a garage with a standing seam metal, side-gable roof. Constructed circa 1950, the garage is of wood-frame construction with wood siding, and it is located northeast of the cottage and north of the first garage.

The third outbuilding is a shed with an asphalt shingle, front-roof. Constructed circa 1930, the shed is of wood-frame construction with wood siding, and it is located northeast of the cottage, north of the first garage, and northeast of the second garage.

The fourth outbuilding is a barn with a standing seam metal, front-gable roof. Constructed circa 1930, the barn is of wood-frame construction with wood siding. The barn is located northeast of the cottage and other outbuildings.

8. Significance (Continued)

Directory and State Gazetteer listed both Episcopal and Roman Catholic churches in Hughesville as well as a Friends' school, four (4) general merchandise stores, two (2) saloons, two (2) undertakers, a wheelwright, a blacksmith, a tobacco buyer, and a population of fifty (50). Gannett's 1904 Gazetteer of Maryland defined Hughesville as a "post village...on the Washington, Potomac and Chesapeake Railroad" (Gannett 1904: 43). By 1906 the community was known as "a station of the Southern Maryland Railroad...and a banking town" with two (2) physicians, two (2) general stores, two (2) blacksmiths, a grist and saw mill, a flour mill, an undertaker and livery, a hotel, a hotel and saloon, a grocer and saloon, an insurance salesman, and a population of 150 (Maryland 1906: 667).

The Frank Canter Property is a front-gable, vernacular cottage. Between 1870 and 1940 the vernacular cottage style was typically built for Americans of modest means. They are characterized by simple ornamentation and mass-produced components, such as door frames, moldings, sash and window units, and porch decoration. The development of post-Civil War machinery capable of producing large amounts of standardized housing elements, such as those found in cottages, contributed greatly to the development of the modern American housing industry. Designs for vernacular cottages were obtained from popular magazines, such as House Beautiful, or carpenter's and builder's journals, such as American Builder. A variety of front-gable, side-gable, cross-gable and hipped roof frame cottages were developed in the early to mid-twentieth century. Front-gable and hipped roof cottages are primarily 1 to 1½-stories tall, 3-bays wide and several rooms deep. Side-gable and cross-gable structures are usually 2 to 2½-stories tall, are typically 2 to 3-bays in width and vary from one to three rooms deep. They usually include a porch covered with a shed roof. Porches are supported by posts often containing machine-produced Victorian ornamentation. Some cottages feature ornamentation drawn from Craftsman style or Colonial Revival architecture (Gottfried and Jennings 1988, viii-xv).

8. Significance (Continued)

National Register Evaluation:

Constructed in 1926, the Frank Canter Property is not eligible for the National Register of Historic Places. The property is not eligible under Criterion A, as research conducted indicates no association with any historic events or trends significant in the development of national, state or local history. Historic research indicates that the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. It is not eligible under Criterion C, as it is an undistinctive example of a common architectural type. In addition, the form and massing of the original cottage have been altered by the construction of the rear shed-roof addition and by the screened porch. Finally, the structure has no known potential to yield important information, and therefore, is not eligible under Criterion D.




