Circa 1900

Howell's Run is a good example of a typical late-Victorian farmhouse and outbuildings which were a common part of the rural Charles County landscape. The farmstead, located on the west side of Route 5 just north of Route 488, includes a circa 1900 two story, double-pile, center passage dwelling that is three bays in length. The house is situated on the top of a small rise surrounded by several mature trees. Dominant characteristics include a center gable at the facade adorned with a square casement window, and a one story full length porch with turned wooden posts and scrollsawn brackets. To the rear of the dwelling are three circa 1930 barns and a heated frame workshop. Non-contributing resources include one frame and two concrete block sheds.

The house was originally part of a 250-acre tract known as Howell's Run, and is associated with the Posey, Bean and Ryon families of Charles County. Together with the three early twentieth century tobacco barns and a heated workshop, Howell's Run is a good sampling of common building forms found on a Charles County farmstead during the early twentieth century.

Howell's Run is a good example of the typical late-Victorian farmhouse and outbuildings associated with the rural Charles County landscape. The farmstead, located on the west side of Route 5 just north of Route 488, includes a circa 1900 two story, double-pile dwelling that is three bays in length and situated on the top of a small rise surrounded by several mature trees. The dwelling has a center passage plan. Dominant characteristics include a center gable at the façade adorned with a square window, and a one story full length shed porch with turned wooden posts and scrollsawn brackets. To the rear of the dwelling are three circa 1930 barns and a heated frame workshop. Non-contributing resources include one frame and two concrete block sheds. The dwelling rests on a solid rock-faced concrete block foundation. Currently the walls are clad with aluminum siding. Asphalt shingles covers the roof and meets the walls at an open cornice. The roof is interrupted by two interior brick chimneys with corbelled caps.

The façade, which faces the southeast, features a central entrance and vertically symmetrical fenestration on the first and second floor with the exception of a three part projecting bay window on the first floor façade. Unlike the other elevations, all of the windows on the façade appear to be replacements, with the possible exception of the attic gable. The first and second floor windows consist of metal double-hung 1/1 light composition. This elevation includes a single panel and light metal door centrally located under the second story window.

The southwestern and northeastern gable-ends mirror one another and feature four symmetrical windows, with two centered on the second floor, and two below. These are double-hung 2/2 light windows which appear to be original. The southwest wall also includes what appears to be a gabled external cellar entrance.

The rear or northwestern elevation also largely mirrors the symmetrical façade with the exception of a later shed addition to the first floor that extends over two of the overall three-bay width. The second story includes three original double-hung wood sash 2/2 light windows, as does the first floor northernmost bay. The shed addition includes a rear entrance with a single panel and light door. Paired windows are placed to the north of this door while a single window is placed to the south. The rear ell windows appear to be modern with double-hung, 6/6 lights, and metal sashes.

Outbuildings

Three tobacco barns are located to the far rear of the property, near the tree line. All have a gable roof sheathed in metal, with vertical board siding.

A low rectangular frame shed is located between the larger barns and the dwelling. The gable roof is covered in metal and the frame is sheathed with vertical board siding. The structure also contains an interior brick chimney with a corbelled cap at the southwestern end and may have been used for stripping tobacco.

While the dwelling appears to be in fair condition, overall the site houses mixed use activities, most notably a concrete block garage located in the center of the barn complex. A row of trailers are also found nearby as well as a modern housing development.

Prepare a one-paragraph summary statement of significance addressing applicable criteria, followed by a narrative discussion of the history of the resource and its context. (For compliance reports, complete evaluation on a DOE Form - see manual.)

The dwelling and outbuildings associated with Howell's Run are representative of domestic and agricultural buildings associated with the rural Charles County landscape during the first quarter of the 20th century.

According to tax records, the dwelling was constructed in 1920. However, land records point to a slightly earlier date between 1892 and 1908. In 1908, Adrian and Mary A. Posey sold to J. Milton Bean 250 acres including buildings and improvements known as "Howell's Run." The property was to James P. and Samuel G. Ryon in 1927 and remained in the Ryon family for over three decades. The heirs sold the property to James Elmer and Beatrice E. Richards in 1961.

The dwelling at Howell's Run is similar to other Charles County dwelling constructed during the first quarter of the 20th century. The two story, three bay composition with a one story porch with a decorative center gable and window dominated domestic architecture in the area for at least twenty five years. Similarly, the outbuildings on the site are also highly typical of regional preferences and include vertical board siding, and metal seam roofs.

Bryantown Vicinity




