The Renner Farm, consisting of a dwelling surrounded by several outbuildings is a good example of a small late Victorian farmstead in Charles County. The dwelling resembles a modest center gable I-house, which was a popular plan for small farm families during the late nineteenth and early twentieth centuries. Two stories high, one room deep, with a one story shed porch and an L- addition to the rear, the dwelling was probably built by Frank Sadler around 1925. In that year Sadler purchased 42 acres from an early land development corporation known as The Farms Company of Maryland who subdivided hundreds of acres in the Waldorf area into farmettes during the twenties and thirties. Since 1936 it has been owned and occupied by the Renner family.

The house is also surrounded by several typical barns and outbuildings including two tobacco barns, a corncrib and a shed. Together these buildings form a good representation of Charles County's rural heritage. Small farms accounted for one-third of all farms in the county during the early twentieth century.

The Renner House was built circa 1924 and is located on the west side of Renner Road near the intersection with Route 5. Situated upon a hill with open fields to the east, this site includes a few scattered mature trees surrounded by a denser forested area. The site consists of a late Victorian, center gable I-house and an assortment of outbuildings including two tobacco barns, two sheds, two garages, a workshop, corncrib or granary and a non-contributing trailer.

The dwelling, which faces east, is a two story three bay frame I-house with a central projecting gable and a one story full length porch. A two-story cross gable wing projects from the rear elevation, creating an L-plan. The house is supported on a solid concrete block foundation. Wall surfaces are covered with asphalt sheeting. The side gable roof is treated with standing seam metal sheathing. The cornice is open. The roofline is broken by one central interior chimney and an exterior concrete block chimney located at the rear wing elevation.

The façade is characterized by a one story shed porch supported by replacement metal poles. Currently, the principal entrance is near the south wall and consists of a single panel and light wood door. A second, probably original, door is centrally located on the first floor. Windows are vertically symmetrical and appear to be original consisting of double-hung sash 2/2 lights with square edged wood surrounds. Second story fenestration includes three identical windows. Within the gabled pediment is a small four light arched attic window.

The north elevation consists of the gable wall of original construction, and the eave wall of the two story kitchen wing. Centered under the gable ridge is a single first floor window with an identical one above. Under the eave wall of the rear wing are two additional windows, one above the other.

The south elevation is composed of a one-story shed addition that wraps around and terminates at the existing west wing wall.

OUTBUILDINGS

Two tobacco barns are located in front of the dwelling to the north and south and probably date to the early twentieth century. Both roof ridges run on a north/south axis. Each features a metal roof, vertical board siding and three lighting rods on the roof ridge. The northernmost structure has significantly deteriorated. The southernmost barn has been altered with the addition of a pent shed roof over the gable-end barn doors. This barn has also been reclad with new vertical boards.

Two small square wooden frame structures are located to the north of the dwelling. Both are front gable structures. The larger of the two is a vertically clad, metal roof structure which may have originally been used as either a corncrib or a granary. The smaller structure has an open wall on the southern façade providing the only access into the interior. This structure is clad with German siding. The frame is supported by a concrete block foundation. It appears that this structure was moved from another location.

To the rear of the dwelling is a frame shed with a sloping metal roof and a paneled wood door. The structure is clad with asphalt sheeting and also features several wooden windows.

To the northeast of the frame shed is a non-contributing concrete block garage, two bays in length with large modern garage doors and a metal roof.

Other non-contributing structures include a concrete block shed located to the southeast of the dwelling, and a concrete block workshop and metal trailer flanking the northernmost tobacco barn described above.

The Renner House site, circa 1924, is a good example of a small late Victorian farmstead in Charles County. The dwelling resembles a modest center gable I-house, which was a common plan chosen by small farm families during the last quarter of the nineteenth and early twentieth centuries. The house is also surrounded by several typical barns and outbuildings including two tobacco barns, corncrib/granary and shed. Together these buildings form a good representation of a small farm which accounted for one-third of all farms in the county during the early twentieth century.

At the turn of the century this parcel had been part of a 152 acre tract owned by the Edelen family and at one time was a part of the property known as "Betsy's Delight". The dwelling was probably built by Frank Sadler around 1925 who purchased the 42 acres from The Farms Company of Maryland. Since 1936 it has been owned and occupied by the Renner family. Originally consisting of slightly over 42 acres, in 1987 the property was divided to its current acreage of 6 acres. Mrs. Margaret Renner, the current owner, moved here as a young child in the 1930's.

The Renner House displays many of the characteristics of a modest center gable I-house, popular in the United States from 1870-1915. If the dating is correct, this is an interesting late version of the popular form. According to Renner, the dwelling was a former tenant house, originally consisting of four rooms. However, this could not yet be substantiated by the archival documentation. Her father, Emil Renner purchased the property in 1936 and added onto the original I-house by constructing a rear, two story kitchen addition.

Many of the barns and outbuildings are typical of those found on small farms in Charles County during the early twentieth century including two tobacco barns, a corn crib, shed and workshop. In 1930, there were 1,592 farms in Charles County. Roughly 1/3 or 499 of these farms consisted of under fifty acres. After the Civil War farm sizes in the county began to decrease as larger farms were divided into smaller tracts. Farms under fifty acres steadily increased to peak at 728 in 1920.




