Circa 1850

Likely constructed during the middle of the 19th century, Wentworth is a two story, single pile, frame dwelling exhibiting modest Greek Revival influences including a shallow pitched roof, a wide cornice, sidelights surrounding the entrance door and two-part mantels inside. The house sits directly on the north side of Prince Frederick, facing south and has an exterior brick chimney with stepped shoulders on either gable end. A full width front porch extends across the facade, and a one story kitchen wing is attached to the west gable end. Sharing the site is a small ruinous corncrib and a late 20th century shed.

Wentworth is a good example of a vernacular interpretation of the Greek Revival style in Charles County. Believed to have been built or extensively remodeled between 1850-1860 by the Rufus and Mary B. Robey, the dwelling was once part of a large parcel including land on both sides of Prince Frederick Road. The nearby Calverton Manor Barn (CH-645) and the William Woodburn House (CH-666) were also associated with this site.

Likely constructed during the middle of the 19th century, Wentworth is a two story, single pile, frame dwelling exhibiting modest Greek Revival influences including a shallow pitched roof, a wide cornice, sidelights surrounding the entrance door and two-part mantels inside. The house sits directly on the north side of Prince Frederick, facing south and has an exterior brick chimney with stepped shoulders on either gable end. A full width front porch extends across the facade, and a one story kitchen wing is attached to the west gable end. Significant later alterations include the enclosure of the front and possibly rear porch of the kitchen wing and a long shed addition extending the full length of the rear elevation. Sharing the site is a small ruinous cornercrib and a late 20th century shed.

The frame structure is currently re-clad in aluminum siding and rests on a continuous brick foundation. The roof is sheathed in asphalt shingles and meets the eave walls with a boxed cornice. The south or front elevation is asymmetrical and includes four 6/6 light double hung wood sash windows on the second floor, above two first floor windows of the same composition. The door is located at the west end of the main block and features a set of three narrow rectangular sidelights on either side below a 4-light transom. Four turned wooden posts support the shed roof porch. The kitchen wing includes an enclosed porch containing two modern 1/1 windows.

The east elevation is without windows except a modern replacement window in the rear ell. This wall is dominated by the stepped shoulder brick chimney with evidence of original corbelling around the cap. This chimney has deteriorated substantially above the roofline.

The rear or north elevation also includes some replaced windows and possibly some altered fenestration. On the second floor two 6/6 light windows appear near the east wall, mirroring those found on the façade. To the right or west of this grouping is a replacement 1/1 window of smaller proportion than the other windows. To the right of this is a boarded window. The enclosed first floor ell includes two c. 1950 2/2 light windows. An exterior door stands in the kitchen wing.

The west elevation includes a single window in the rear ell and an exterior brick chimney flue with a corbelled cap. Attached to the kitchen wing is a square exterior brick chimney flue with a corbelled cap. The west chimney of the main block reveals decorative corbelling at the top.

Wentworth is a good example of a vernacular interpretation of the Greek Revival style in Charles County. Believed to have been built or extensively remodeled between 1850-1860 by the Rufus and Mary B. Robey, the dwelling was once part of a large parcel including land on both sides of Prince Frederick Road. The nearby Calverton Manor Barn (CH-645) and the William Woodburn House (CH-666) appear to have also been associated with this site.

In the 1850 census for Charles County, Rufus Robey is identified as a schoolteacher living in the household of merchant, James T. Thomas. Thomas is believed to have occupied the Patuxent City House (CH-122) in the nearby 19th century village of Patuxent City. In 1858, Rufus Robey married Mary B. Porter of Newark, Delaware. By 1860, Robey was 33, and Mary, age 26. He owned \$2000 in real estate and \$500 worth of personal property. Also living in the household was the first of their four children, Helen, schoolteacher Charles Porter of Delaware and mechanics James Gross and Washington Curtis.

The Robey's acquired over 200 acres in the vicinity of Patuxent City by purchasing smaller adjacent tracts. Much of this property was held by wife Mary B. Robey who, at the time of her death in 1881, granted a life estate to her husband Rufus. Rufus Robey was an active figure in Charles County life. In 1862, he held a trader's license with James Cochran and James T. Thomas at Patuxent City. He served as Justice of the Peace in 1861, and as chairman of the Oyster Monopoly meeting in 1860.

The dwelling is one of only a handful of documented local examples of the Greek Revival influence on the vernacular architectural traditions in Charles County. As the dominant architectural style in America between 1830-1850, the Greek Revival style was inspired by an awakening of interest in classical Roman and Greek forms. First seen in public buildings, Greek Revival details eventually spread to influence domestic architecture. In many rural examples such as Wentworth, Greek Revival elements were attached to traditional plans.





7. Description

Wentworth was first surveyed in February 2001 at which time the interior was not accessible. A recent field visit revealed that the existing two-story single pile Greek Revival-influenced structure incorporates an earlier 15' x 15' 1 ½ story structure found in the east wing. The first floor includes two rooms on the first floor main block with an open stair passage located to the east of the door. The east room, consisting incorporating the pre 1850 structure reveals ghost marks of two previous doors on the north and south walls. Surviving exterior siding from the Period I structure can be found in the closet under the Period II stair. Around 1850, the roof was raised and an addition was attached to the west wall, creating the existing main block. Although there is little visible evidence to date this structure, land records suggest the presence of several buildings on the various parcels assembled by Mary Robey beginning in 1865.

The interior appears to have been extensively remodeled with a drywall drop ceiling added in the late 20th century. However, some original doors and hardware have survived. Surviving 19th century features include a 2-part mantel, turned newel, and 4-panel interior doors with applied molding. Although contemporary finishes largely obscure original features in the kitchen wing, the presence of an exterior brick chimney flue suggest a late 19th - early 20th century construction date.
