Standing conspicuously on the northeastern corner of the intersection between Brentland Road and Fergusen Feusse Place, the Loch Leven cornhouse is an excellent example of 19th century agricultural architecture in Charles County. Once associated with the nearby 18th century dwelling of Loch Leven, the structure retains almost all of its original materials. Four bays in length, the heavy-braced frame building is set on a replacement concrete pier foundation. The front gable roof extends over the outer walls in wide eaves. Original wood shingles are visible under the current metal roof. During the mid 19th century, the dwelling, outbuildings and surrounding 660 acres, was owned by Barnes Compton, president of the Maryland Senate from 1868-1870.

Prepare both a one paragraph summary and a comprehensive description of the resource and its various elements as it exists today.

The Loch Leven cornhouse, constructed during the middle of the 19th century, faces south and stands conspicuously on the northeast corner of the intersection of Brentland Road and Fergusen Feusse Place. Once associated with the nearby 18th century dwelling of Loch Leven (CH-43), the parcel containing the cornhouse has been subdivided and now includes approximately 90 acres. Retaining almost all of its original materials and features, the cornhouse consists of a 1-story, heavy-braced frame building set on a concrete pier foundation. The front gable roof extends over the outer walls in wide eaves. Hewn corner posts and intermediate posts support a hewn plate overlaid by joists that support a false plate. Down braces reinforce the corners and several interior vertical posts. The front and rear gables are clad in horizontal lapped wood siding, and the roof has been recovered with corrugated metal sheets. The interior of the crib is accessed through a wide panel door centered on the south gable end.

The Loch Leven Cornhouse is a large, four bay heavy timber framed structure believed to be constructed during the mid- 19th century. Containing a high degree of original material in a rural setting, it is an important reminder of Charles County's agricultural heritage.

Following the War of 1812, Charles County experienced a period of economic stability. Although competition from other tobacco-growing regions intensified during the first half of the 19th century, the large-scale planters seem to have maintained their economic stability. By 1820, most of the out migration caused by the depredations of war and the inability of small tenant farmers to prosper had ceased. Tobacco prices became unstable, and remained so throughout the early 19th century. However, the wealthiest of the landowners in the county remained prosperous. Many diversified their interests, investing in corn or wheat cultivation or in commercial industries, such as milling, fishing, and commerce.


