The Issue Store and Post Office is a deteriorated one-story, painted concrete block and brick commercial structure standing on the west side of Rock Point Road in Issue. Constructed in 1932, the building has a stepped façade and a 2-room open interior plan. The storefront faces east and includes a shallow shed porch supported by square wooden posts. A large cedar marks the site of a gas pump directly in front of the building.

The Issue Store and Post Office is a good example of civic/commercial architecture in Charles County from the second quarter of the 20th century. The structure is closely associated with the development of the Southern Maryland Truckline which follows present day Rock Point Road. This was the first large-scale, State road-building project in Charles County, and as a means of transporting farm produce to markets, the road had a profound impact on the development of the geographically isolated Cobb Neck region.

The Issue Store and Post Office is a deteriorated one-story, painted concrete block and brick commercial structure standing on the west side of Rock Point Road in Issue. Constructed in 1932, the building has a stepped façade and a 2-room open interior plan. The storefront faces east and includes a shallow shed porch supported by square wooden posts. Unpainted brick is used to at the window sills and as a cap for the stepped commercial front. The façade includes a total of two doors and four windows, all 6/6. A large cedar marks the site of a gas pump directly in front of the building.

The interior is divided into two rooms, the larger of which was likely used as a store and contains a row of wooden built-in shelves along the rear wall. Currently, large commercial coolers and shelving are stored inside. The smaller room was not visible at the time of the survey but may have been used as the post office.

A small 2-room, frame shed-roof garage, also fronting Rock Point Road, stands directly to the north (to be surveyed).

The Issue Store and Post Office is a good example of civic/commercial architecture in Charles County from the second quarter of the 20th century. The structure is closely associated with the development of the Southern Maryland Truckline following present day Rock Point Road, the first large-scale State road-building project in Charles County. As a means of transporting farm produce to markets, the road had a profound impact on the development of the geographically isolated Cobb Neck region.

Since 1920, Charles County has experienced major changes in its economy, demographics, and physical development. To a large extent this development was spurred by substantial transportation improvements throughout the county, beginning with the construction of the Southern Maryland Truckline in the 1920s. In its original conception, the concrete road connected Rock Point at the end of Cobb Neck, to Waldorf and on to Baltimore. Eventually, this highway was named U.S. Rt. 301, or Crain Highway after Robert Crain, a prominent Cobb Neck resident who was instrumental in lobbying the state for funds to build the road. The Southern Maryland Truckline made automobile travel speedy and convenient for both farmers transporting goods to market in Baltimore, and for passengers doing business or visiting outside the county.

The road also opened the area to tourism, as urban and suburban dwellers sought to escape to the country for a day or a weekend. Robert Crain himself developed Cobb Island, at the tip of Cobb Neck, as a summer getaway for Washingtonians and other waterfront development quickly followed. Woodland Point, Wicomico Beach and Banks O' Dee were just a few of the waterfront communities that sprang up overnight. Improved transportation and an influx of weekend and seasonal residents encouraged the establishment of service-related facilities including general stores, filling stations and repair shops.


