

**Doctor Thomas L. Higdon Farmhouse and Office**  
**CH-701**

Established at the turn of the 20th century, the Dr. Thomas L. Higdon Farmhouse and Office, also known as "Pleasant View" is situated on a high rise overlooking the Potomac River valley in Cobb Neck. The 87 acre farm is anchored by an attractive Victorian farmhouse surrounded by a few domestic and agricultural outbuildings including a smokehouse, dairy, corncrib and ruinous stable. The frame two-story, three bay I-House is one room deep, and embellished with a characteristic decorative center gable and wrap-around porch. A two-story rear service wing extending from the northwest corner forms an overall L-plan. Victorian ornamentation consists of bracketed porch columns and fishscale shingles in the porch gable. Extensive landscaping in the form of terracing is visible in the steep decline from the dwelling's façade to the main road.

Thomas Lawson Higdon was born in 1868 near Pisgah at his family home known as "Planter's Delight". He graduated from Charlotte Hall Military Academy in 1889 and after teaching for several years, entered medical school at Georgetown University and the University Baltimore. Soon after receiving his M.D. in 1898, he set up an office at his home serving the maritime and agricultural communities of the Cobb Neck region until his retirement around 1950. One of his notable accomplishments was the establishment of an early health insurance policy with local organizations including the Watermen and Oystermen Association and the Willing Helpers Association. In 1989, a nearby elementary school was renamed in his honor.

Established at the turn of the 20th century, the Dr. Thomas L. Higdon Farmhouse and Office is situated on a high rise overlooking the expansive cultivated fields of the Potomac River valley in Cobb Neck. The 87 acre farm is anchored by an attractive Victorian farmhouse that faces southwest. The dwelling is surrounded by a few domestic and agricultural outbuildings including a smokehouse, dairy, corncrib and ruinous stable. The frame two-story, three-bay I-House is one room deep, and embellished with a characteristic decorative center gable and wrap-around porch. A two-story rear service wing extending from the northwest corner forms an overall L-plan. Victorian ornamentation consists of bracketed porch columns and fishscale siding in the porch gable. Extensive landscaping, in the form of terracing is visible in the steep decline from the dwelling's façade to the main road.

The dwelling rests on a brick pier and infill foundation. The standing seam metal roof is pierced by two interior brick chimneys and equipped with a weathervane and lightning rod. The cornice is boxed and a decorative center gable holds a 3-light arched window. Original working shutters and 2/2 windows are found throughout with the likely exception of paired 6/6 windows in the rear wing of the dwelling. The hipped roof porch rests on concrete piers and is adorned with a decorative center gable of a lesser pitch than the center gable of the main block. Original weatherboard siding has been reclad with asbestos shingles.

The symmetrical façade includes three bays with three windows above and two below. A transom and sidelights surround the centered entry way. Moving clockwise, the northwest gable elevation has single windows, centered on each of the first and second stories. On this elevation, the service wing exterior wall is flush with the main block and holds four asymmetrical windows on the second story. The first floor includes two 2/2 windows near the main block and a pair of 6/6 windows to the rear. The rear gable elevation of the kitchen wing is without fenestration. The southeast elevation of the service wing includes three second story windows. The first floor has two door and two windows. One door is sheltered by the wrap-around porch. The other, flanked by windows, is open. The rear of the main block consists of a single second story window in the southernmost bay and one directly underneath on the first floor. A fourth door is found near the interior service wing corner.

The interior was not available for study at the time of the survey.

### OUTBUILDINGS

To the west of the dwelling stand a pair of front gable outbuildings facing the drive. Both are sheathed in vertical board siding and attached with late machine cut nails. Each has a centered vertical plank door. The larger of the two served as a smokehouse stands on a fieldstone pier foundation. The other, believed to be a dairy, includes single windows on each of the eave walls. This structure, believed to be a dairy is entirely paneled with closely laid interior plank.

A small front gable corncrib with a metal roof stands to the northeast of the dwelling. It has a centered vertical plank door. The frame is exposed with narrow slats nailed to the interior of the structure. Near the corncrib is a collapse stable.

### DOCTOR'S OFFICE

Standing roughly opposite the smokehouse and dairy, the doctor's office is a one story front gable building built into a slope. The frame structure, sheathed in original novelty siding, rests on a poured concrete basement accessed from the rear elevation. A shed roof porch resting on narrow turned wooden posts protects the dual entryway flanked by windows on the exterior. Two windows are set symmetrically on either eave wall, while the rear elevation is without fenestration. All windows, doors and hardware appear to be original as does the pressed tin roof. The porch floor is of poured concrete. A small square 4-light window is set in the center of the front gable above the porch.

The Dr. Thomas L. Higdon Farmhouse and Office is an outstanding example of late 19th century architecture and one of only a few examples of a intact physician's office in Charles County. Thomas Lawson Higdon was born in 1868 near Pisgah at his family home known as Planter's Delight. After attending Charles County schools he graduated from Charlotte Hall Military Academy in 1889. Higdon taught for several years and then entered medical school at Georgetown University and later the University of Baltimore. He received his M.D. in 1898. Soon after he established an office at his home, also known as "Pleasant View". Higdon practiced there until his retirement around 1950.

Dr. Higdon primarily served the maritime and agricultural communities of the Cobb Neck region. In 1989, a nearby elementary school, constructed on land owned by his wife Ella Norris, was renamed in his honor. At the time of the school's dedication, local residents recounted memories of this country doctor who visited patients in a horse and buggy. At times he would travel to the water's edge, before meeting fishermen to escort him to treat lighthouse operators in Morgantown and Cobb Point. His fee schedule was \$1 for an office visit, \$2 for a house call and \$5 for a night visit. Higdon arranged an early health insurance policy with local organizations. Patients who belonged to the Waterman and Oysterman Association and the Willing Helpers Association paid premiums of \$1 a month and the associations paid Higdon \$1 for his treatment, including medicine. Country doctors provided the only form of medical care in Charles County until the construction of the first Physicians Memorial Hospital in 1939.






