The Charles Sweetney House is a ruinous example of the simple vernacular structures erected by African American at the turn of the 20th century. The dwelling stands in the village of Bel Alton on four acres deeded to Sweetney in 1895 by members of the Cox family of nearby Rich Hill (CH-177NR). The house consists of a 2-part side gable frame dwelling covered with a standing seam roof and weatherboard siding. The main block has a two rooms on the first and second floors divided by a thin partition. A quarter-turn corner stair provides access to the second story from the smaller of the two rooms.

The Charles Sweetney House is a ruinous example of the simple vernacular structures erected by African-Americans at the turn of the 20th century. The dwelling stands in the village of Bel Alton on four acres deeded to Sweetney in 1895 by members of the Cox family of nearby Rich Hill (CH-177NR). The house site is approached by an unnamed lane which once connected Doctor Spencer Road to Bel Alton Newtown Road and provided access to this dwelling along with the adjacent, now demolished John Henry Kelly House (CH-736) which was similar in form.

The house consists of a 2-part side gable frame dwelling covered with a standing seam roof, weatherboard siding adhered with wire cut nails, and a single exterior end chimney. The frame stands on a foundation of locust posts. The east gable end includes the attached one-story kitchen wing. The main block measures 20 feet wide and 16 feet deep. The front elevation is three bays in length with a centered doorway flanked by 4/4 windows on either end. The roof span is 23 feet. A 20th century porch once sheltered the entrance but has now collapsed. The side elevations of the main block are without fenestration. The rear elevation includes only a single doorway. The kitchen wing is 14 feet in length. The front elevation has a door near the main block opposite a window. The opposite rear wall has a centered window.

The main block has an overall hall and parlor plan with the main door leading into the largest of the two first floor rooms. The smaller room includes a quarter turn stair. A partition has been added to create a hall passage and to provide privacy for the attached room. The kitchen appears to have been a later addition. Interior details in the main block include 4-panel doors, tongue and groove paneling throughout and sea-green wall paint. Beds in the small stair room indicate this was used as a sleeping quarter.

The Charles Sweetney House is a representative example of the types of vernacular structures built by African-Americans in the late 19th century. In December 1895, Samuel Cox Jr. and Nannie Cox, his wife sold to Charles Sweetney four acres of ground described as just outside the northernmost corner of the recently surveyed Bel Alton town lands, including existing buildings and improvements. Bel Alton, originally known as Cox's Station, was the first railroad town in Charles County to offer daily passenger service to Bowie, beginning in 1873. Early on it rivaled La Plata, as a bustling rail town.




