Description of Property and Eligibility Determination *(Use continuation sheet if necessary and attach map and photo)*

This small wood frame house is one story high and three bays wide. Vernacular in style, the house is also marked by a front gabled, one bay wide porch roof which has no supports.

Located in the town of Waldorf, this house reflects patterns of residential development that characterized Waldorf in the early-20th century. Following the Civil War, railroads made the greatest impact upon community development in this area, particularly the completion of the Baltimore and Potomac Railroad's (B & P) main line from Bowie in Prince George's County to Pope's Creek in Charles County in 1872. Small towns, like Waldorf, grew when they became regular stops on the B & P line, and developed as service centers for the surrounding rural areas. As a result, by 1887, Waldorf grew to contain a Methodist Church, a school, two general stores, two saloons, and two hotels. By the beginning of the 20th century, road improvements and the use of the automobile brought increased traffic and further development to the region.




