<p>This small house has an interesting arrangement on the facade. It is composed of two one and one-half story, two bay sections, each having a door and a window. The entrance in the taller of the two parts has a two-panel door with four-pane transom, while the lower portion has a door with sidelights and transom. To the rear of the latter section is a one story kitchen wing. The entire structure is covered with brown wood shingle and the roof with light asphalt shingle. There is a brick chimney in the northeast gable of each part as well as in the kitchen.</p>


