DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>Algonquin was built in 1895 overlooking the Choptank River. It is a large brick two and one-half story dwelling, five bays long with extensions on the southwest and southeast sides. It bears classical details and would most probably be called Classical or Colonial Revival style, but it is very plain. The three dormers actually cut through the cornice of the house and consequently it looks quite tall. Across its facade is a one story porch with columns supporting a classical cornice. They inturn are seated upon a classical base. The windows have 2/2 sash throughout, with the exception of the window above the double entrance door. It has side windows covered at present with louvered shutters.</p> <p>The southwest wing appears to have been designed as a sun room, as it has a row of small-pane windows on each face of both storys. This portion of the house appears more Renaissance in proportion than the remainder of the house. The southeast extension houses the kitchen and other rooms and has irregular fenestration, although it is the same height as the main body of the house.</p>

STATEMENT OF SIGNIFICANCE

Algonquin is important as a late 19th century structure as well as being the site of an aboriginal settlement which has been ravaged by amateur archeologists.

Laskowski Papers

"About 1838 it was purchased by James Pattison who presented it as a wedding gift to his daughter Henrietta who married John T. Stewart, a cousin of Judge Stewart, on Jan. 27, 1838. John T. and his wife were the parents of fourteen children, all born at Sandy Hill. (A)

Henrietta died April 25, 1885 aged 68 years; her husband died Oct. 6, 1882 aged 67 years. (A)

About 1895 the property was purchased by Joseph Mundy who built the present beautiful home of brick. (B) It was then purchased by U.S. Senator Raynor of Maryland whose home was in Baltimore and who used Algonquin as a summer home. It was Senator Raynor who changed the name from Sandy Hill to Algonquin. Later it was sold to a Mr. Basshor, of Baltimore, whose wife was the first wife of Isaac Emerson, the originator of Bromo-Seltzer. (A)"
