DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>This house is a three bay long by two bay deep frame structure with a three bay wing. On the west side of the building is another addition, part containing a bay window like Waterloo, on the adjoining property. The entire structure is built close to the ground and is covered with wood shingles painted white. Over the central entrance is a Greek Revival portico which protects the door with its double hung sidelights and transom from the weather. Most of the windows have 6/6 sash. An "A" roof covers the building and from its rear (west) slope rise two brick chimneys. The north chimney being mostly on the exterior of the house while the south chimney is mostly within the gable.</p> <p>The wing sits back and is connected at about the back one fourth of the principle structure. It is a simple three bay long structure with an "A" roof. A portion of the wing has a projecting room, covered by a catslide roof, toward the river.</p> <p>The floor plan of the principal portion of the house was similar to the second story of Indian Purchase, i.e. it had a stair hall and small room on the east side of the house with two rooms behind. Only the two walls enclosing the stair hall remain however. The latter retain original Greek Revival trim, with corner blocks bearing rosettes. The mahogany stair has turned newel and plain conically turned balusters. In the ceiling of the hall is a plaster disc from which hangs a lighting fixture.</p> <p>Although the trim is similar in the living room (composed of three original rooms) the corner blocks are not as detailed and less so in the remainder of the house. Both fireplaces have mantels, but the south mantel appears to pre-date the house, at least stylishly, by 20 years. The latter has a cushion friere supporting the shelf which bears a course of reeding. The opposite mantel is typical of simple mid-19th century work. Behind the south room is a dining room with fireplace on the west wall, flanked by two windows, with gyb doors beneath. Its north is a screened porch and on south the wing, previously mentioned.</p>

STATEMENT OF SIGNIFICANCE

Vue de L'Eau is one of the few buildings in rural Dorchester County which was built with Greek Revival details. It was once a part of the Choptank Indian Reservation. The tract of ground was purchased in 1799 by Samuel LeCompte and later was the home of the Stewart's and Dixon's.

North of the house is an Indian shell mound indicating the site of an Indian village.


