DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>Wayside Farmhouse is a two and one-half story frame structure, three bays long with large chimneys enclosed within the gables. To the east is a two story wing, two bays long and on the back of the wing is an "L" with a still more recent one story flat roof wing.</p> <p>The portion which is of interest is the first mentioned. It appears to date from the fourth decade of the 19th century and retains most of its original detail, except the second floor east window, which has been doubled, and the siding, which is asbestos. It is built on a brick foundation, has a south entrance porch and west porch, the former leading to the central bay of the facade.</p> <p>Inside, the house originally had two rooms and stair hall, but since one wall has been removed, there are only two rooms. Despite the alteration, most of the other wood-work appears original. The mantels are the most impressive of elements due chiefly to their large scale.</p> <p>West of the house is a burying ground containing stones bearing the names of Vickers and Monroe. The earliest dates from 1800 and bears the name West.</p>

STATEMENT OF SIGNIFICANCE

Few buildings in Dorchester appear to date from the 1840's. For this reason, as well as the fact that the form of the house is typically vernacular, the building must be considered in a survey of architectural forms, styles and periods.
