<p>Cedar Grove stands on the upper reaches of Beckwith Creek across from Beckwith Chapel. It is a two part house, both three bays long with two windows and a center door in each, a one story kitchen, and a two story main section. On the second story of the main section there are only two windows. There are two doors on the facade but one was at one time a window. On the south side of the house there has been an extension built to the kitchen, and one of the second story windows of the main portion was lengthened, undoubtedly for ease of transporting furniture to the second floor. The walls are covered with asbestos siding and the roof with asphalt shingle. There are three chimneys within the gables. It is like many of the vernacular structures of the early 19th century. It is very similar in appearance to the original Great Hopes in Queen Anne's County.</p>

Cedar Grove is important architecturally because it is unique to the county, although not unlike some of the frame houses on Taylor's Island. The difference is the lack of the third window on the second story.
