<p>The Rhodesdale Depot is a one story frame structure standing near Rt. 14 at Rhodesdale. Its facade has a door with single window on the right side and a bay window on the left. There is a wide hood supported on brackets on three sides of the structure and a leanto addition on the back. The walls of the structure are covered with asbestos siding but a small gable above the hood on the west gable retains its original board and batten siding with circular vent.</p>

STATEMENT OF SIGNIFICANCE

Transportation obviously holds an important place in the development of commerce in the late 19th century. The depot is one carryover of the days when passenger service was available to points north and south.

Sometime prior to 1944 the Baltimore and Eastern Railroad discontinued service and in that year it was moved to its present site from the other side of the railroad and the highway. In 1946 it became a store for which it is still used.
