<p>Joseph's Right is a handsomely restored early 19th century structure composed of two portions of nearly equal length, but one being lower than the principal portion. The walls are covered with twentieth century beaded weatherboard. Each section is two bays long plus a central door. The west gable also possesses windows on both storys flanking the exterior chimney. A second chimney also stands on the outside of the east gable. On the south facade there is a leanto, enclosed porch across the lower portion and a small pedimented porch in front of the front door of the main part. There are recent additions on the north side of the house.</p>
