<p>North Joseph's Right is a typical one and one-half story frame early nineteenth century vernacular dwelling house with some twentieth century alterations. The main part of the house is about the size of Margaret's Delight near Hudson, composed of a three bay section with two chimneys and a one bay wing, the same height as the main portion. In addition to the main part, there is also a one story kitchen wing with a screened porch and large chimney. All of the chimneys have been re-built, the siding replaced and, prior to the present restoration, the dormers enlarged to shed dormers with double windows. There is also a leanto off part of the back for bath and utility areas.</p> <p>The interior consists of a living room, a corridor and bedroom, a dining room and kitchen. Original board paneling and mantels exist in the living room and bedroom.</p>

STATEMENT OF SIGNIFICANCE

Some of the interior detail is very similar to the interior of Buck Range across the Creek. The building is an important vernacular dwelling and is significant as such. It was owned by members of the North family in the 19th century and in the 1870's there existed a wind-mill on the property east of the house.
