<p>Whore's Wharf is almost identical to the old portion of Home Farm on the east side of Bar Neck. It is a two part, frame structure composed of a three bay long, two story part with a two bay long, one story part. In addition, it also has an enclosed leanto porch on the south end and another across the east facade of the main portion. Like Home Farm and Billy Wheeler Farm, the fenestration is assymetrical and the chimneys are located on the outside of the gables. The kitchen sash has been changed to 2/2 sash, but the remainder appears original. The weatherboard may have been replaced.</p>
