<p style="margin: 0;">Covey Point house is one of the attractive small houses of the Neck District, though it does not have the age that many of the dwellings possess. It consists of a central one and one-half story, board and batten structure with a one story wing on each side and a one and one-half story wing on the north. There is a screened porch across the facade from which is had a view across a cove of Brannock Bay. The house is painted yellow and stands along side of a huge old white oak tree, which is similar to the old tree at Old Trinity Church Rectory near Church Creek.</p> <p style="margin: 0;">Inside, the house consists of two rooms with an enclosed stair between the two, and a fireplace in the larger room. The period woodwork is very simple, as is typical of the mid-19th century.</p>

STATEMENT OF SIGNIFICANCE

Covey Point is significant because it represents a farther development in the hall and parlor house. The earliest form is found in the Rubye Brooks house, Woolford; a later example is typified in Indian Cove, Church Creek, where the stair ascends in the middle of the house. Other examples of this type are Spocot and Dorothy's Discovery. Covey Point and Spedden's Delight are the last of the hall and parlor, one and one-half story houses, though the plan is used frequently in two story balloon framed dwelling of the last half of the nineteenth century.
