DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

South of Deal's Right on Casson Neck is a small early house which has been greatly remodeled over the years. It is a one and one-half story house with two old sections, Both of which originally consisted of the same fenestration. There is a door and window with a dormer above on each section. From the proportions of the window in the taller portion it appears to have had 9/6 sash. The dormers have 6/6 sash. The brick piers have given way to a complete foundation of concrete block. There was probably a fireplace in the larger portion of the house between the two sections.

Onto the south end has been added a hip roof addition and a one and one-half story extension. The walls of the dwelling are covered with asbestos siding and many of the windows have 1/1 sash and 2/2 sash.
