<p>On the shores of Brannock Bay stands the previous home of the Marshall family. In 1924 the family built the present farmhouse and have used the previous house for storage. The earlier building was similar to the lower wing of Oyster Creek Farm. It has two center doors and two windows on each story of the one and one-half story building. Only one of the chimneys remain, on the southwest gable, where there is also a leanto, which was a former kitchen. The former dwelling is built on brick piers, the walls are covered with weatherboard and the roof is covered with tin.</p>
