<p>Ellsworth Marshall's House is a three bay long, two story frame dwelling with a one story wing on the north and a low two story wing on the south. Both of the wings are two bays long. It is covered with asbestos siding and the roof is asphalt. There is a brick chimney within the south gable of the main part and one on the outside of the north gable. A partly enclosed porch is built onto the west side of the south wing. Most of the windows have 6/6 sash, although the north wing, as well as the second floor south wing, has 2/2 sash, which appears to date from around the turn of this century. The main body of the house looks to date from around the mid-19th century.</p>
