DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an L shaped two story frame house with a gabled portion toward the rear, and a gabled wing projecting toward the street on the east side of the front. There are three bays in this wing and two bays across the front of the portion toward the rear. An L shaped porch spans the front facade. It is supported by Doric columns and has a ballustrade. The house has been covered with "ersatz" siding that is now in need of paint.
