DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>The house is a small true one and one-half story frame structure, built on part of the Dail Tract. It has been in the Barnett family since 1887, the year in which the present owner was born. It appears to date from the third quarter of the 19th century, and according to Mrs. Barnett, was the home of two bachelor Dail brothers.</p> <p>It has a three bay facade and two dormers project through the roof just above the cornice. Inside of this house is only two rooms. It has an enclosed stair in one corner of the living room, the other is the kitchen. To the west side of the house Mrs. Barnett's daughter and son-in-law have added a large section with a gambrel roof, which is the reason I looked at the house to begin with, but the gambrel roof section is a 20th century addition.</p> <p>The farm is adjacent to the Woodland Farm which is owned by Ralph Jackson and was the home built by his great-grandfather, a Mr. Dail.</p>

STATEMENT OF SIGNIFICANCE

Few buildings in this survey date from the 1880's, although there certainly were many dwellings built at that time. The form of the building is different from other dwellings encountered in the county, due chiefly to the fact that it is a true one and one-half story structure. It post-dates Dorothy's Discovery which is similar. Earliest structures of this form also exist in Talbot County, specifically in St. Michael's.
