This L shaped frame house has two bays on the front plus a gabled wing that projects toward the street. On the front of this wing is a two story polygonal bay window. There is another full length bay window on the east facade. Across part of the front is a two story porch, supported by rectangular columns and a plain ballustrade. Between the columns on the first story are flat arches.


